


First of all: a refresher...

What did we start again?

During a visit to an agricultural project in Sierra Leone in 2023, we experienced how luxurious our life in the Netherlands is with clean and safe drinking water from the tap.

In Sierra Leone and many other countries, there is no clean tap water: people simply get drinking water from a water



That prompted us to start an initiative:

## Making clean drinking water accessible to 4,000 families in Sierra Leone.

which makes babies and children sick or even die. 8% of children die before their 5th birthday!

## Annual overview, from inception December 2023 until December 2024.

## 1. Establishment and paperwork (January → May)

The foundation was established on December 21, 2023, with enthusiastic support from the Notariaat Westerwolde.

In December, we also received a "kind" donation from a plastic bucket manufacturer who offered us a pallet for free.





In order to be fully operational as a foundation quickly, we already applied for the first applications for a bank account with ABN and ING in December, after first assessing the options with, among others, Triodos (minimum 26-week waiting list), RABO-Bank and Regio-Bank (both did not accept new foundations in December 2023)

Furthermore, we **developed a website**, which was published online mid-February 2024 and the application for ANBI status was also issued on March 25! (ANBI status makes your donations tax deductible in NL)

However, obtaining a bank account turned out to be a challenge: The ABN application was rejected after about 6 weeks, and a response from

ING was still not forthcoming. Therefore, an application was submitted to BUNQ as a second option, which quickly became available in the course of March.

By mid-May, we finally were granted an ING bank account, which was reason to start using the ING account as our primary bank account.

# 2. Our first practical experiences. (February→ May)

The donated Pallet with buckets caused our first learning experience with the "trade" in West Africa: delay techniques (creating higher storage costs) by the logistics service provider in Sierra Leone, and the high costs for import and transport of the buckets to Sierra Leone. This was an important reason to purchase necessary products much as possible in Sierra Leone from that moment on.

After these difficulties, the pilot project in **Malal Chiefdom** could start in early May. Our local project coordinator, Mr Osman Orisa Sesay, a head teacher started distributing the Water filter sets and instructions for 40 farmer families. (See photos below) )







#### 3. Building a new relationship network: entire year.

Early in the year we were able to participate in a few **Wilde Ganzen** network meetings, although we are not (yet) a partner. We made useful contacts with foundations that are already working in Sierra Leone. This quickly provided new insights and the opportunity to exchange knowledge. After that we



participated with a stand in two other events: In June the "Planty of Food Festival" in Apeldoorn and in August the Annual **Summer Outing** of the Diaspora of Sierra Leone.

During the Outing (Photo Left) we were able to meet the Ambassador of Sierra Leone, who later after an online presentation turned out to be so enthusiastic about the clean drinking water concept that he and five embassy employees ordered a Filterset set for their own families in Sierra Leone.

## 4. The first (pilot) project in Malal. (May → November)

From the first deliveries of goods from the Netherlands, **Murphy's law** has always played tricks on us: what CAN go wrong, almost always has gone wrong. Starting with the delay in the deliveries of the purchased Tulip Filters and the free buckets, up to and including the illness of our project coordinator and an accident of his wife, which naturally temporarily gave the project lower priority.

In the end, during the pilot project from May to November, only a small 20 of the locally available 40 Tulip filter sets were delivered to families. A disappointingly low number. Fortunately, the users were very satisfied with the clean drinking water!

During our November visit to Sierra Leone, in addition to visits to Freetown and other cities and villages in the country, we also visited the pilot project area in **Malal Chiefdom** and jointly evaluated the

objectives and results. The most important lessons for us were: the lack of sufficient progress information and ownership from the local project management.

Reason for us to end this project and to take up new, more promising initiatives with a more critical eye. This decision was partly determined by visits to the other local drinking water development projects that we visited in November.

As a thank you for the pilot project in Malal, the Foundation offered a Tulip water filter set to the primary school (Photo right), where our project coordinator worked until his retirement.

Preparations for a new project for 2025 have already started with

one of the locations visited in November: a combination of clean drinking water and repair of a water well: the village of Matam, with 50 families, is taking ownership of the structural acquisition of clean and sufficient drinking water and household water with our help. The families save a small contribution every week, sufficient to be able to maintain both the water well and periodically replace the Tulip water filters in the future.
